WELCOME TO THE PERSEVERE STUDY



PERSEVERE is a national study funded by the National Institutes of Health, led by Dr. Jori Fleisher at Rush University Medical Center in Chicago, IL, which is testing an educational program for family caregivers of people with Parkinson's Disease with cognitive impairment, Parkinson's Disease Dementia, Dementia with Lewy Bodies, or Lewy Body Dementia. PERSEVERE will test whether a disease-specific, caregiver-centered educational intervention improves caregiver knowledge, confidence, strain, and health outcomes - and whether it helps people living with Parkinson's Disease Dementia, Dementia with Lewy Bodies, or Lewy

Body Dementia, too. Family caregivers will receive weekly educational guidance through a 12-week curriculum with resources and activities. **All participation is virtual and scheduled when it works for you. There are no in-person visits** and the person with Parkinson's Disease, Dementia with Lewy Bodies, or Lewy Body Dementia does not participate--just caregivers. **For more information, please go to**:

IN CELEBRATION OF A LIFE WELL-LIVED! MARTIN ADLER

November 11, 1946 - June 11, 2024



Dr. Martin E. Adler was born on November 11, 1946, in Long Branch, New Jersey. He was a devoted husband, father, brother, grandfather, friend, and physician. On June 11, 2024, at the age of 77, Martin passed away peacefully in San Diego, CA, following a long struggle with Parkinson's Disease. Consistent with his humor and love of finding patterns in numbers, he was born on the 11th day of the 11th month, passed on the 11th day at the 11th hour, and at an age divisible by 11.

Growing up in the small town of Oakhurst on the Jersey shore, Martin attended grammar school in Ocean Township and high school in nearby Asbury Park. He met the future love of his life, Eileen Keppler, when he was only five years old-and she was four. Eileen had shared a double carriage with her twin brother, and her parents gave it to the Adler family when Martin's younger twin brothers were born. Martin attended Rutgers, the State University of New Jersey, and then medical school at Tufts University in Massachusetts. He completed his medical training in

Boston, then-with his new wife, Eileen, and their first son, Jeremy-moved west to attend the University of California at Davis for a fellowship in endocrinology. Although Martin claimed that he was drawn to endocrinology to treat diseases of the thyroid, his journey took him to become an expert in diabetes. He practiced medicine for nearly 30 years upon relocating to San Mateo, California, where he and Eileen purchased a home and welcomed their second son, Matthew. Martin eventually became the head of endocrinology for San Mateo County General Hospital. He was noted for his commitment to serving all patients with compassion and dignity. Martin retired in 2003, and he and Eileen moved to San Diego in 2005 to be closer to their first grandson.

Martin understood the importance of physical and mental activity, enjoying sports throughout his life. A long-standing fan of the Giants and Padres, his appreciation for baseball began in high school when he played first base. Martin was always open to trying new activities, including running, completing the Bay to Breakers race in San Francisco, tennis, golf, swimming, biking, and Tai Chi. He enjoyed camping across Europe in his 20s and spending summer and winter weekends with his family at their cabin in the Sierra Nevada mountains. A dedicated father, Martin actively fostered his two sons' interests, attending Boy Scouts events, Little League games, martial arts tournaments, and school band concerts. Also passionate about motorized vehicles, Martin enjoyed going to classic car shows with his grandsons and often reminisced about the motorcycle he rode during college.

During his illness, Martin was a constant fighter, extensively researching treatments and freely sharing his knowledge with others. He even took up Rock Steady Boxing to combat his illness. Martin bravely participated in the cutting-edge therapy of implantable deep brain stimulation, which was remarkably successful. He was such a supporter of this therapy that his clinical team produced a short documentary about his experience. Up until late in his illness, Martin could be seen taking long bike rides along the San Diego beach and bay. He was routinely biking with two other friends, who both also had brain stimulators. They would jokingly call themselves the "metal heads." Although the illness was incurable, Martin always maintained a remarkably upbeat and positive attitude, looking for reasons to celebrate, even his half-birthdays. He had certain goals later in life: to remain living at home and to visit the beach, even after he could no longer take his beloved bike rides. Two weeks before his passing, with family in tow and a grin from ear to ear, he cruised up and down the beach with the help of his sons and a specialized wheelchair, exuding pure joy.

Martin is survived by his wife of nearly 55 years, Eileen, and their two sons, Jeremy and Matthew. Martin and Eileen were married in New Jersey on August 17, 1969, which happened to be the same weekend as the Woodstock music festival in New York. Eileen is a retired teacher, avid knitter, and author. Jeremy practices as a Physician Associate in San Diego, specializing in pain management. He and his wife Danielle have two sons, Jacob and Jesse. Matthew is an attorney who lives in San Francisco, California with his wife, Sarah. Martin is also survived by his older brother, Steve, and twin younger brothers, David and Paul. To further Parkinson's research, donations may be made to The Michael J. Foundation.

Clinical Trial Title

PERSEVERE in Lewy Body Dementia: A Randomized, Controlled Trial of Peer Mentor Support and Caregiver Education

National Clinical Trial Number:

Clinical Trial Protocol Description:

This randomized, controlled trial involves a 12-week behavioral intervention (PERSEVERE) for Lewy Body Dementia (LBD) family caregivers comprised of discussion of and coaching through specific LBD knowledge and social support topics during weekly phone calls with a trained caregiver peer mentor (interventionist), guided by a practical, health literacy-friendly handbook (PDF and website versions available).

The active group of mentees (intervention) will be compared with caregivers randomized in a 1:1 fashion to an education group (attention control) condition who will receive a weekly, emailed list of links to pre-existing educational content on LBD. The PERSEVERE intervention is delivered by caregiver peer mentors, a cadre of experienced current or former LBD family caregivers who will be recruited and trained as part of the study.

Clinical Trial Eligibility Criteria:

In order to participate you must meet the following criteria:

- Are at least 18 years of age.
- Are English-speaking.
- Are currently cohabitating with or spending >10 unpaid hours weekly on caregiving
 for a family member diagnosed with LBD, as measured by LBCRS, OR have met
 these criteria in the past if the family member with LBD is deceased.
- Are US-dwelling.
- Have access to and are comfortable with telephone use, including adequate hearing or appropriate assistive devices to communicate by phone.
- Have access to and are comfortable with internet use, including a working email address and adequate vision or appropriate assistive devices to be able to open and read email communications and participate in an online mentor training session.
- Demonstrate capacity to consent to research participation.
- Have no known terminal diagnoses or life expectancy < 2 years, by self-report.
- If PLBD is alive, their cognitive symptoms or visual hallucinations have been present for 2 or more years.
- If PLBD is alive, PLBD is community-dwelling at the time of enrollment; subsequent placement in a facility does not exclude continued participation.

You will be excluded from the study if any of the following criteria apply to you:

- Are not at least 18 years of age.
- Are not English-speaking.
- Do not currently cohabitate with or spend >10 unpaid hours weekly on caregiving for a family member diagnosed with LBD, as measured by LBCRS, OR haven't met these criteria in the past if the family member with LBD is deceased.
- Are not US-dwelling.
- Don't have access to and are not comfortable with telephone use, including adequate hearing or appropriate assistive devices to communicate by phone.
- Do not have access to and are not comfortable with internet use, including a working email address and adequate vision or appropriate assistive devices to be able to open and read email communications and participate in an online mentor training session.
- Cannot demonstrate capacity to consent to research participation.
- Have any known terminal diagnoses or life expectancy < 2 years, by self-report.
- If PLBD is alive, their cognitive symptoms or visual hallucinations have been present for <2 years.
- If PLBD is alive, PLBD is not community-dwelling at the time of enrollment; placed in a facility at the time of screening.

Is Your Parkinson's Disease Medication Not Working Well Enough?

JOIN OUR CLINICAL TRIAL

The physicians at UC San Diego Health are seeking patients to test a new, experimental procedure for Parkinson's disease.

QUALIFICATIONS

We are looking for volunteers ages 40-69 who have had Parkinson's disease for at least 5 years, and whose medication isn't working well to control their symptoms.

STUDY DETAILS

Patients interested in this study will be evaluated by a movement disorder specialist from UC San Diego Health's Neurology department. They will undergo a series of assessments to determine the severity of their Parkinson's disease symptoms (how much they interfere with activities of daily living), as well as routine blood and imaging tests to determine if they qualify.

Selected participants will undergo surgery, during which they will have cells engineered to produce dopamine — a hormone that plays a role in movement, motivation, and learning — injected deep into their brain. All testing, procedures, and related care will be provided at no cost to participants; health insurance is not required. Participants will need to continue to provide their own Parkinson's disease medications, however, as they will not be provided by the study.

Participants' medical records and identity will be kept strictly confidential. A stipend to cover travel expenses will be provided to qualified participants at each in-person visit. They will need to provide their own transportation.
